NOTES

(A) - External wall finish
 (A1) Forticrete Shearstone Walling Stone, Light Ham, Random Bonding Pattern.
 (A4) Pebbledash render finish, Ashtone cream or similar.
 (A5) 100mm stone returns.
 (A6) Dry stone wall to match existing context.

(B) - Roof covering
 (B1) Slate roof, Thrutone by Marley, or similar approved.

(C) - Windows
 (C1) Double glazed PPC aluminium window. Colour: RAL 9001.
 (C2) Double glazed PPC aluminium rooflight.

(D) - Sills and precast elements
 (D1) Precast concrete, forticrete colour PORTLAND or similar.
 (D2) Precast concrete sill, forticrete colour PORTLAND or similar.

(E) - External doors
 (E1) Hardwood door. Colour: RAL 5023.
 (E2) Double glazed PPC aluminium sliding door. Colour: RAL 9001.

(F) - Rainwater goods
 (F1) Lindab Rainline Steel RWP's and hopper.
 (F2) 227 Litre water butt.

(H) - Fences
 (H1) 1800mm timber post fence.
 (H2) Galvanised metal balustrade with obscured glazing. Colour: RAL 5023.

(K) - Landscaping
 (K1) Courtyard pavers, 300x600mm Bradstone Panache textured SILVER FLECK.
 (K2) Driveline Piora permeable paving, 200x100x60mm, charcoal.
 (K3) Garden, drought resistant soft landscaping.
 (K4) External bike store.
 (K5) External storage space for separate general waste and recyclable waste bins.
